**THAT** the project will help achieve the Oregon Department of Transportation performance measure targets for safety;

**THAT** the proposed changes to the TIP are consistent with the management process established in the adopted TIP; and

**THAT** for Project Key Number 22692 [Polk County Striping & Marking Improvements], the Preliminary Engineering phase be advanced from the draft 2024-27 TIP to the 2021-24 TIP for delivery in FFY 2023.
